# Department of Devasthan Information Jaipur, December 2, 1991

G.S.R. 41:- Section 14, Section 17, Sub-section (2) of Section 20, Sub-section (4) of Section 21, Section 22, Section 41 of Mr. Sawaliyaji Mother Adhyayan Desh 1991 (Ordinance No. 10, Year 1991) In exercise of the powers conferred by sub-section (3) of section 28, the State Government hereby makes the following rules to carry out the purposes of this Ordinance, namely:-

### 1

#### 1. Associated name and initials:-

- 1. These rules may be called the Shree Saviyaji Mandar Rules, 1991.
- 2. These will come into force with immediate effect.

#### 2. Definitions:-

- (1) In these regulations, unless there is anything repugnant to the subject or context:-
- (a) "Ordinance" means the Shri Sawaliyaji Maldar Ordinance, 1991;
  - (b) "Budget" means the statement of receipts and estimates of expenditure of Shri Saviyaji Mandir.
  - (c) "Balance Sheet" means the Budget Satyanu Chitra (Balance Sheet) of Shri Saviyaji Mandir.
  - (d) "Board" means the Board established and run under section 5 of the Ordinance by Shree Saviyajim Vidaram Board having its office at Manviya village in Chittaurgarh district.
  - (e) "Form" means the forms appended to these rules.
  - (f) "section" means a section of the Ordinance.
- (g) "year" means the financial year beginning on the 1st day of April and ending on the 31st day of March next following that date.
- (h) "service" means all kinds of service which is done in connection with the distribution of idols or any other aspect set out therein.

- (i) "Mildaran Fund" means the Saviyajim Virdaram Fund administered by Mr. Saviyajim Virdaram Borah and all sums in it, offerings, gifts and any other donations or contributions made for the benefit of the Paju place and includes such sums; The Paju place and the services of Shri Saviyaji are also agreed upon for the purposes under Paju.
- (j) "officers and employees and servants of the Board" means any such officer and employee, other than the Chief Executive Officer, appointed by the Board or appointed by a person authorized by the Board, agreed.
- (k) "Jewellery ornaments" means gold, silver and other precious metal ornaments, gemstones and other articles which are made to be worn by the vatau or are used as pajau kaya.
- (I) "Construction work" includes the construction, repair, alteration, addition, construction and new construction work of Saviyaji Temple complex and other buildings and buildings administered by Mr. Saviyaji Madriman Boha and works related to agriculture and irrigation of the temples which are Manviya or Works carried out outside Manviya and construction works carried out by the Donors carried out by the Board or with the consent of an officer authorized by the Board, etc., are included in this.
- (2) Words and expressions used in these rules but not defined shall have the meanings respectively assigned to them in the Ordinance.
- (3) Unless otherwise required in good faith, the Rajasthan General Clauses Act, 1955 (Rajasthan Act 8 of 1955) shall

have the same force for the purpose of interpretation of these rules as it applies for the purpose of any Rajasthan Act. I
